- Actually found the insole socks could be taken out under normal force and some would have foreign body sensation during fitting due to the glue lump caused by poor gelatinizing.
- 2. Factory provided reference sample for compare during inspection. The factory arranged one worker to check the fitting test for reference.
- 3. Actually found the upper surface of the product had slight crease due to the packaging method.
- 4. Actually found the trace of the mold at the heel of the outsole was obvious.
- Because the surface of the product is suede, the fluff in different directions will show different colors.

- 7. Found have no warning text on poly bag which opening beyond to 18cm (only have air hole).
- 8. There is no anti-cutting cardboard for protection when opening the carton.
- 9. No packing and label details was provided from clients for comparison during inspection.
- The factory cannot provide equipment for adhesion test of outsole. The inspector simulated the abuse usage by end consumers to check it, but only for reference.
- 11. The factory has no equipment to test the adhesion of fluff.
- 12. The packing list provided by factory.
- 13. The factory has no laboratory test certificate.
