- The factory said the actual shipping quantity was 10560pcs instead of 10500pcs, and 10470pcs were packed into cartons when inspector arrived.
- For Grey,the color of bulk products was lighter than approval sample and color swatch. The color shade was 4-5.
- 3. The factory could not provide the equipment for GSM test.
- Actually found the size of care label on the product was about: 5.4x3.2cm and the size of the sample (before sewing) was: 6 x3.2cm.
- 5. Since the final buyer did not provide the reference sample, label and packaging requirements of the product for reference during the inspection, this inspection is based on the clothing inspection process and mainly finds out the quality problems of the product. The factory provided approval sample without client's signature, the size and packing information was given by supplier to inspector for reference during the inspection. Please refer to the actual inspection photos for details.
- No tolerance was provided for size check, please check the size table.


